Certified under the Dispute Resolution Programs Act, Mr. Dudics has mediated hundreds of cases, both for the court system, and as a private mediator.

A trial attorney since 1990, Mr. Dudics entered the practice of law after a successful career as a biomedical engineer/programmer for American Hospital Supply. He has extensive knowledge of medical technology, terminology, and procedures; and brought this expertise to his trial practice in defense of personal injury actions ranging from soft-tissue auto accidents to claims of brain damage, amputation, and wrongful death. He has worked as in-house counsel for Allstate Insurance Company, and was Senior Trial Attorney for Infinity Insurance Company. As outside counsel litigating premises and products liability actions; his representative clients have included Universal Studios/Amphitheater, Dow Corning, American Stores (Sav-On/Osco Drugs), Ace Hardware, and Radiator Specialty Company (Liquid Wrench, Gunk Brands).
